A young family in Colorado is suing an apartment complex after they unknowingly moved into an apartment that had been used as a Meth lab. Their two-year- old daughter became very sick within days of moving into the unit.

In Ohio, a single mother is suing the former owner of a drug house that she bought. She was forced to vacate the house, lose most of her personal belongings and face foreclosure after learning of the home's history.

+++++++++ In Washington State, a property seller and his Realtor recently lost an appeal against damages they were ordered to pay a buyer for failing to disclose a Meth lab. The former owner's tenants had cooked Meth on the property's porch.

If you work in property management or real estate, you could face situations similar to the above, while anyone who enters homes or deals with the general public could be in danger from Meth lab contamination or a confrontation with a Meth user, who is often paranoid and violent.

For your own safety, it is important for you to arm yourself with as much information as possible on this issue, including awareness and recognition of a harmful situation, types of health and safety concerns, and strategies to protect yourself and your clients.
